John Silver asked if this was being presented to the exec. and the board after a commitment was made. It was explained by Carolyn that no commitment had been made, and that the committee had been ready to present this at the January meeting, but had been asked to delay the presentation. The committee was trying to keep to the schedule so that the art can be hung this year.

The executive will endorse this project to the board. The committee will make the presentation.
